1. City Neighborhood Groups Can Apply for Grants

The City of Knoxville is reopening the Neighborhood Small Grants Program (NSGP) to provide funding for neighborhood-based initiatives in the city.

Approximately \$30,000 has been made available for projects developed by resident-led, resident-controlled neighborhood associations, tenant associations, homeowners associations, and neighborhood watch groups that serve neighborhoods inside city limits. Start-up neighborhood groups may also apply.

As announced in the January 9 issue of this newsletter, groups wishing to apply must send a representative to either one of two **mandatory** pre-application workshops scheduled for 5:30 p.m. Wednesday, January 28, and 5:30 p.m. Thursday, February 5, at the Cansler Family YMCA, 616 Jessamine Street.

Applications are due March 23, and awards will be announced in mid-May for projects starting in July.

Neighborhood groups can apply for grants ranging from \$250 to \$2,500. To increase the impact of the city's funding, grants must be matched with donations of goods and services, volunteer labor and/or other financial support for the project. Please review these documents prior to the workshop and before calling the Office of Neighborhoods (David Massey, 215-3232) with any questions or concerns. Many questions can be answered by reading the guidelines and looking over the application.

The NSGP was created in the 1990s by the East Tennessee Foundation and then was later funded by the City of Knoxville in collaboration with the Foundation. The two partners

suspended the program after the 2011 grant cycle. Now the Office of Neighborhoods is reviving the program on its own but with the advice and counsel of the Foundation.

2. Last Call: Nominate the Good Neighbor of the Year

If you know someone who has been an especially active and caring neighbor, you have just a few more days to nominate him or her for the Diana Conn Good Neighbor of the Year Award.

The award is presented annually to a Knoxville resident who --- in a spirit of cooperation and with commitment to inclusive community --- has devoted time and talent in service to his or her neighbors and neighborhood.

Nominations will be accepted through Wednesday, Jan. 28, 2015. The nominee must be a resident of the City of Knoxville. Mayor Madeline Rogero will present the award at the Neighborhood Conference to be held Saturday, March 7, 2015, at the Knoxville Convention Center.

6. CAC Offers Free Lead-Based Paint Assessment and Related Work

There are ways to protect children in your home from lead-based paint hazards.

Did you know that many homes built before 1978 may contain lead-based paint? Young children under the age of 6 are especially susceptible to lead exposure. If lead paint chips are ingested, even with low levels of lead, it may affect a child's development and ability to achieve in school. The most important way to protect children from lead-based paint hazards is through prevention.

If you are concerned that lead-based paint hazards are present in your home, the Lead Safe & Healthy Homes Program --- operated by CAC Housing & Energy Services --- may be able to help. Check the date your home or apartment was built. If it was before 1978 and you have children under the age of 6 that live there or visit regularly, you could benefit from an assessment.

Eligible applicants to the Lead Safe & Healthy Homes Program will receive a free lead-based paint assessment and related lead hazard control work.
