Subcommittee Reports

Audio/Video:

Committee member Star Starks provided the Audio/Video Report for the 1st Quarter.

Of the two (2) Referral Action Forms and two (2) Internal Affairs Cases reviewed by the PARC, there were two (2) cases with documented audio and video recordings (or lack thereof) based on body

worn cameras and/or the incident taking place in the vicinity of the officers' patrol vehicles and within a recordable range.

The Audio/Video Subcommittee submits the following findings for our 1st Quarter review:

The Knoxville Police Department's General Order 2.16 (Digital Audio/Video Recording Equipment) details that Officers and vehicles equipped with audio/video recording equipment shall be in a record mode at all times when there is potential for contact with a person in the community, whether on-duty, or during secondary employment. The purpose of digital audio/video recording equipment is to monitor all contacts with a person in the community in all situations possible.

We would also like to mention that the Knoxville Police Department requires Sergeants to review officers' audio and visual footage twice per month to ensure that their equipment is operating properly.

Racial Profiling:

Committee member Jered Croom provided the Racial Profiling Report for the 1st Quarter.

There were no alleged racial profiling/bias based policing cases reviewed by PARC during the first Quarter review.

KPD Policy and Procedure Reviewed:

General Order 1.41 Bias Based Policing

I. Policy

It is the policy of Knoxville Police Department that we are committed to preserving the peace and maintaining order in the City of Knoxville by practicing bias-free policing and respecting the rights and dignity of all citizens.

II. Definition

Bias Based Profiling- The practice of stopping, detaining or searching a person based solely upon a common trait or a group that includes but is not limited to their race, color, ethnicity, age, gender, sexual orientation, religion, economic status, or any other identifiable group characteristic.

Training Session:

Prior to addressing Case Matters, Sgt. Rachel Britt of KPD's Internal Affairs Units provided an overview of the Investigative Process.

Case Matters Addressed by the Committee:

The committee addressed 11 out of the 13 cases reviewed during the 4th Quarter. Matters addressed are as followed:

File 1: Referral Action Form

No questions were asked regarding this case.

File 2: Referral Action Form

1. Is there any clarifying reason as to why knowledge of arrest (providing reason) cannot happen prior to handcuffing or simultaneously?

KPD is not trained to announce the reasoning for the arrest prior to handcuffing the suspect. In the case that if KPD made the announcement prior to handcuffing, there's potential for the suspect to disagree and the situation can escalate in various ways. Hence, because it is a safety issue for both the officer(s) and public, suspects are detained first then an explanation is provided after.

File 3: IAU Case #21-2864

1. Was an audit of the officers' previous overtime slips, and if so, did the officer return any money he was incorrectly paid?

There was an audit of all overtime slips submitted by the officer. The officer was not paid any additional money based off of the incorrectly submitted slips due to Payroll quickly identifying the issue and halting processing.

File 4: IAU Case #21-2850

- 1. What is the expected battery life of an officer's individual body camera at a charge of 44%? It's extremely hard to approximate that. If video is offloading wirelessly through the in-car system, if it's paired to the Sonim phones for streaming, how long/often it's activated are all factors that add increased draw on the camera battery. At a guess at 44%, with no additional factors such as those above, I would say there should be 4-5 hrs. of life left. The more active the officer is, the shorter that time is.
- 2. Are there any car chargers for the body cams?

 There are, but they are slow charge-chargers. There are also docking stations available for officers to charge while attending roll call.
- 3. What is a way to help officers keep the cameras more readily available?

 Supervisors have extra body cameras and can provide a camera if officers are in need.
